**ESSENTIAL QUALIFICATIONS:-**

A Postgraduate Medical Degree (MD/MS/DNB) in respective discipline from recognized university/Institute.

**Note:-** If candidates i.e., MD/DNB are not available/eligible in any particular specialty, those who are having 02 years Post Graduate Diploma after M.B.B.S in the concerned specialty can be considered.
