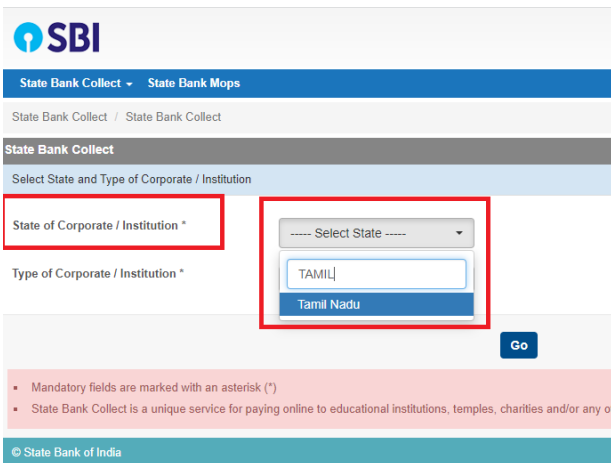

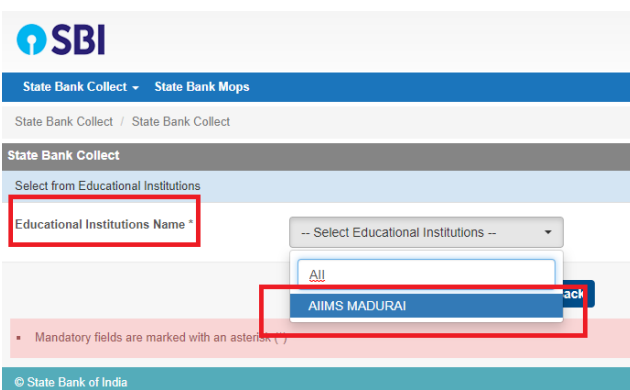

**TERMS AND CONDITIONS FOR CONTRACT APPOINTMENT**

1. The appointment is purely on CONTRACT BASIS and will be initially for a period of **11 months with effect from the date of joining** and extension will be granted for further period, if it is required by the administration. If the contract is not extended further, the same will lapse automatically.
2. The appointment can be terminated at any time before the expiry of the period of 11 months referred to above, with one month's notice without assigning any reason or if the person's work is considered unsatisfactory by the Competent Authority.
3. If the appointee wishes to resign his/her job, he/she has to serve one month's notice or remit one month's salary or pay thereof, as the case may be proportionate to the shortfall in the notice



period.

4. The appointee shall perform the duties as assigned to him/her. The Competent Authority reserves the right to assign any duty as and when required. No extra/additional allowances will be admissible in case of such assignment.
5. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion, Allowances etc. or any other benefits available to the regular employees of this Institute.
6. The appointee shall not be granted any claim or right for regular appointment to any post at AIIMS, Madurai.

## **DEFINITION OF CATEGORIES**

### **i) Unreserved (UR):**

Unreserved stands for all applicants including OBC/SC/ST/EWSs. (Only such OBC/SC/ST/EWSs candidates who are selected on the same standard as applied to general candidates shall be treated as own merit candidates. If any OBC/SC/ST/EWSs candidate is selected by getting any relaxation in age, etc., he/she shall be counted against reserved vacancies. Such a candidate cannot be considered for appointment against an unreserved vacancy)

### **ii) Other Backward Classes (OBC):**

Applicants are required to ensure that he/she does not belong to the persons/sections (Creamy Layer) mentioned in Column 3 of the Schedule to the Government of India, Department of Personnel & Training O.M. No. 36012/22/93-Estt. (SCT) dated 08/09/93 which is modified vide OM No. 36033/3/2004 Estt. (Res.) dated 09/03/2004 or the latest notification of the Government of India (i.e. Central list) in support of his/her claim.

### **iii) Scheduled Caste / Tribe (SC / ST):**

Applicants are required to produce the necessary certificate as prescribed in M.H.A., O.M., No. 42/21/49-N.G.S. dated the 28.1.1952, as revised in Dept. of Per-& A.R. letter No. 36012/6/76-Est. ### **iv) Persons With Disability (PWD)**

The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability. The Percentage of the candidates' disability will be assessed by medical board and the decision of the medical board will be final in this regard.

The disability certificate should be submitted. It should be certified by a duly constituted and authorized medical board of the State or Central Govt. Hospitals/Institutions.

### **v) Economically Weaker Sections (EWS):-**

Candidates who are not covered under the scheme of reservation for SCs, STs and OBCs and whose family has gross annual income below Rs.8.00 lakh (Rupees Eight Lakh Only) are to be identified as EWSs for benefit of reservation. Income shall also include income from all sources i.e. salary, agriculture, business, profession, etc. for the financial year prior to the year of application.

Also persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWS, irrespective of the family income:-

- i. 5 acres of agricultural land and above;
- ii. Residential flat of 1000 sq. ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- iv. Residential plot of 200 sq. yards and above in areas other than the notified municipalities.

The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.

The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years. (As per the Office Memorandum F.No.36039/1/2019 dt 31st January 2019 by Ministry of Personnel, Public Grievances & Pension & F.No.A11013/01/2019 dt. 28th February 2019 by Ministry of Health & Family Welfare, Government of India)
