### I. Conditions for Eligibility:

1. Nationality : Only Indian Nationals are eligible to apply.
2. Age Limit: Between 18-32 years:  
Crucial date for determining the age limit: **Age will be reckoned as on the date of interview i.e. 23.08.2018.**
3. **Interested and eligible candidates may attend the interview along with filled in application form, self attested copies of testimonials and Bio-data. (Annexure attached).**



III. **Mode of Selection:**


Based on **Written Test followed by interview** for the shortlisted candidates conducted by this Department. Both Written Test and Interview will be held in the ratio of 85:15.

IV. **TERMS & CONDITIONS**

1. The period of contractual engagement will be initially for a period of 40 days in respect of 2 Nos. of ANM and the extension will be granted if required by the administration for the further periods.
2. The contractually engaged persons will not have any claim for permanent or regular employment in this Institute as this is purely a temporary contractual engagement and will remain valid up to contractual period for which the engagement is approved on each occasion.
3. The contractually engaged persons will not be eligible to get official accommodation/quarters allotment within the campus as applicable to the other regular employees of this Institute.
4. The contractually engaged persons shall in no case represent or give opinion or advice to others in any matter which is adverse to the interest of the Institute.
5. Canvassing of any kind will lead to disqualification.
6. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
7. The appointment is full time and private practice of any type is prohibited.
8. **The contractually engaged persons may have to work in shifts including night shifts and can be posted at any place in JIPMER – Urban Health Center / Rural Health Center.**
9. The contractually engaged persons are expected to conform to the rules of conduct and discipline as applicable to the institute employees.
10. The contractually engaged persons should not have been convicted by any Court of Law.
11. In case any information given or declaration by the candidate is found to be false or if the candidate has willfully suppressed any material information relevant to his appointment, he/she will be liable to be removed from the contractual engagement and any action taken as deemed fit by the appointing authority.
