
A separate schedule containing the details of items put up for sale, the conditions of the Tender, the Tender application forms can be download from CPP Portal or JIPMER website. No Demand Draft / Cash/Postal Order/Money order/Telegraphic Money order will be accepted.

The duly filled in application along with TWO payment receipts duly self-attested and rubber stamped should be enclosed (1. Tender application cost including 18% GST Rs.590/-, 2. EMD 5% of upset price for Scrap items Rs.1,38,400/- & for E-waste items Rs.22,500/- to be paid through SBI collect only) and firms (tenderer) PAN card and GST registration copy should be enclosed. In case of e-waste items valid Government registered e-waste disposable vendor certificate should also be enclosed.

All sealed Tenders in the prescribed form should be sent, duly super scribed "TENDER FOR SALE OF CONDEMNED WOODEN FURNITURE, SCRAP EQUIPMENTS, INSTRUMENTS, IRON ITEMS, STEEL ITEMS, ELECTRICAL ITEMS, AIRCONDITIONER, PLASTICS, ETC. (COSTLY AND NON COSTLY) & E-WASTE ITEMS" due on 30.01.2024 at 04.00 pm, so as to reach The Officer In-charge of Central Stores, JIPMER, Puducherry-6 on or before 30.01.2024 at 04.00 P.M. TERMS AND CONDITIONS:

1. SEALED TENDERS are invited by the Director, JIPMER, Puducherry-6 for the “Sale of Condemned Wooden Furniture, Scrap Equipments, Instruments, Iron items, Steel items, electrical items, Air-conditioner, Plastics, etc.. (Costly and Non Costly), Linen items & E-waste items” so as to reach The Office of Central Stores, JIPMER, Puducherry-6 before **04:00 P.M. on 30.01.2024** Tenders received after the due date and time will summarily be rejected.
2. Details of items available for sale are given at the last page. (Annexure – I & II)
3. Tenders will be opened at **11.00 A.M. on 31.01.2024** before the representatives of the Tenderers. Authorized representatives may be present at the time of opening, if they so desire. One representative will be allowed for each Tender. If this date in any case, happens to be a holiday, the due date and the date of opening will automatically be postponed to the next working day, at the same timings.
4. Goods and Services Tax (GST) @ 18% over the rates quoted should be paid by the successful Tenderers’ for all items and the rates quoted should exclude the charges for taking delivery ex-premises of JIPMER which should be borne by the Tenderers at their cost and risk.
5. The tender will hold good for acceptance up to 25 days from the due date of the tender. The successful Tenderer, on receipt of orders from this office should clear the entire quantity “AS IS WHERE IS CONDITION”.
6. The items put up for sale can be inspected by the interested Tenderers at the Central Stores or at the Place(s) earmarked by this office, between 10.00 AM to 01.00 P.M. on all working days from **10.01.2024 to 30.01.2024**.
7. The tender application form can be downloaded from CPP Portal or JIPMER website.
8. The firm (tenderer) should download the tender application from the CPP Portal or JIPMER website and should fill all the required details, and quote the amount for the **Lot ‘A’ & Lot ‘B’**

Rs.27,68,000/- (Rupees Twenty Seven lakhs Sixty Eight Thousand only, Inclusive of 18% GST) as per the upset price fixed by committee for Lot ‘A’.

Rs.4,50,000/- (Rupees Four lakhs Fifty Thousand only, Inclusive of 18% GST) as per the upset price fixed by the committee for Lot ‘B’

If GST is not mentioned separately in quoted amount it will be considered as inclusive of GST(18%).

(Successful Tenderer of Lot 'A' can take resources/items available in the Condemnation Yard, JIRHC, Ramanathapuram & SSB Annex. for Lot 'B' can take resources / items available in the Condemnation yard and should clean the Condemnation yard without debris)

9. a. Tender application cost (Non-refundable): Rs. 590 (including 18% GST) **to be paid through SBI collect only**
b. Earnest Money Deposit: Rs.1,38,400/- for Lot 'A' & Rs.22,500/- for Lot 'B' to **be paid through SBI collect only**. The EMD shall be returned without interest to the non-successful tenderers after acceptance of award of contract by the successful bidder.
c. The duly filled in application along with **TWO** payment receipts duly self-attested and rubber stamped should be enclosed (1.Tender application cost including GST, 2. EMD 5% of upset Price), including firm pan card copy, Govt. registered e-waste vendor and GST registration copy should be enclosed and reach by POSTAL (Register or Speed Post) / COURIER on or before the due date to the following address failing which the tenderer will be rejected. **If GST is not mentioned separately in quoted amount it will be considered as inclusive of GST.**

10. Tenders not accompanied by the E.M.D. payment will be rejected summarily. No interest will be allowed on the E.M.D. The E.M.D. paid by the unsuccessful tenderers will be refunded after fifteen days, only on written requisition and that too, after the sale process is completed.
11. The E.M.D. paid by the Tenderers will be forfeited if they withdraw their tenders before the finalization of the Tenders by the Director, JIPMER, Puducherry-6. If they like to withdraw their tenders, they can do so, on a written application explaining the reasons for withdrawal to be submitted to the DIRECTOR, JIPMER, Puducherry-6 to reach him on or before the due date. Thereafter no withdrawal of Tenders will be entertained.
12. The Director, JIPMER, Puducherry-6 reserves the right to accept or to reject any item or items of offer full or part or cancel the tender at his discretion without assigning any reasons there for.
13. If the Director, JIPMER, Puducherry-6, at his discretion, finds the highest offers quoted by the Tenderers not reasonable in any case to the value of the materials put up, then he will have the right to reject /cancel the entire tender.
14. The successful Tenderer, on receipt of intimation from JIPMER, should remit 25% of the quoted price through SBI collect as Security Deposit (SD) within seven days. Full payment of the quoted price to **be paid through SBI Collect only** within fifteen days i.e. the total value plus Inclusive of GST 18% on the Sale value. The scrap items to be taken delivery between 9.30 A.M. to 4.00 P.M, within 25 working days from the date of intimation. **NO PART PAYMENT WILL BE ADMITTED.** In addition, the successful tenderer has to pay Income Tax @ 2% for the whole tender amount (Total Cost). The IT will be rounded to nearest Rs.10
15. Items should be taken delivery on payment within twenty five working days (25) between 9.30 A.M. to 4.00 P.M. from the Central Condemnation Stores of this Institute from the date of receipt of intimation letter from the JIPMER at the expenses of the successful tenderer(s). **(Welding / any kind of machine should not be used for cutting of materials inside the campus area)**

16. In case of belated payments, a penal interest of 18% per-annum shall be levied by the Director, JIPMER, Puducherry-6 on the sale value up to a further period of twenty five working days. After the expiry of extended period no payments will be accepted under any circumstances, and the E.M.D. paid by them will be forfeited and their offer of Tenders will be treated as cancelled. In such cases, the Director, JIPMER, Puducherry-6 reserves the right to decide further either to accept the offers of the next tenderers or to cancel the entire tenders totally.
17. Failure to clear the materials within Twenty five days (25) days as stated in clause 15 will result in extra payment of rental charges also @ 2% on the sale value per month. However if the materials are not cleared within 25 days from the date of intimation, no claim thereafter will be entertained and the amount paid towards the cost of the materials plus E.M.D. will be forfeited.
18. Failure to comply with the requirements of clause 15 to 17 will lead to forfeiture of the entire amount of E.M.D. to Govt. No request for partial forfeiture of E.M.D. under any circumstances will be entertained.
19. The Director, JIPMER, Puducherry-6 reserves every right to cancel the sale at any stage before the materials are cleared OR before the due date of the Tender, without assigning any reasons therefore.
20. The Tender Application forms can be downloaded from CPP Portal or JIPMER website (www.jipmer.edu.in). Demand Draft, Cash / Postal order / Money order / Telegraph Money order / by person will not be accepted. This office is not responsible for any Postal delay of the receipt of Tender.
21. **“Every Tenderer must go through the Terms and conditions carefully and understand them”** and sign as a token of Agreement of all conditions and submit the same along with their rates. No excuse that the conditions have not been read or understood will be entertained later. One set of schedule with their rates duly signed by them in each page should be submitted, while another set can be retained with them.
22. Every correction in the Tender schedule should invariably be initialed by the Tenderer, failing which the Tender will be liable for rejection.
23. The intending Tenderer(s) should produce an income Tax clearance certificate along with their Tenders.
24. Any attempt on the part of the Tenderers or their Agents to influence the Department in their favour by personal canvassing with the officers concerned will disqualify the Tenders. In case any difference or dispute arises in connection with this contract, all legal proceedings relating to the matter shall be instituted in the court within whose jurisdiction the sales officer voluntarily resides i.e. Pondicherry.
25. Please define upset price. All the Disputes arising out of this tender should be settle as per law of land within jurisdiction of Puducherry. Defaulters will be blacklisted as per rules. Any type of canvassing is prohibited all the taxes in force will apply from time to time. Tender should be submitted in sealed cover. If any fraudulent procedure is adopted by the Tenderer / contractor. They will debarred from tender and blacklisted accordingly.

- 26. The Vendor should have either GST register Number or under GST Composition Scheme.
- 27. Only Government registered e-waste disposable vendor can participate in Lot B (E-waste items)
- 28. The EMD shall be returned without interest to the non-successful tenderers after acceptance of award of contract by the successful bidder.
- 29. The EMD / SD of Successful tenderer will be returned only after completion of work including cleaning of the Condemnation yard without debris. No interest will be allowed on the E.M.D. / SD
