Nominations are invited from IB/GB members of JIPMER or by Directors of Central Govt. Institutes or Vice Chancellors of Central Universities for the award of a Distinguished Chair of Eminence in JIPMER International School of Public Health, containing all particulars of the nominee.

**A) Attributes essential for the Chair**

The Chair will be awarded to those with unquestionable and exceptional credentials to enable intellectual pursuit & to contribute to the development of new & less established fields of the Institute.

The prospective awardees should have made seminal contribution to the field of medical sciences and national/international understanding. He/She should preferably be fellow of all the National Science Academies.

**B) Qualification & Experience for the Chair:**

The nominees/awardees shall have either medical qualification or a researcher whose work is of relevance to human health.

The awardees shall be highly qualified and experienced, superannuated or likely to be superannuated within 6 months. The candidates should be above 65 years of age and the upper age limit for them at initiation shall not be more than 67 years.

**C) Tenure of the Award:**

The initial tenure of the award will be three years which can be extendable for another 2 years after assessment of progress and plans.

**D) Consolidated Remuneration:**

The remuneration will be Rs. 1 Lakh per month in addition to the pension that he/she may draw. The remuneration shall be liable to Income Tax. A contingency grant of Rs. 5 Lakh per year will be provided which may be utilized for meeting/travel (India and abroad), research fellowships & other expenses. Additional contingency grant may be given on project basis. No private practice will be allowed during the tenure of the award.

**E) Output expected:**

The incumbents are not only meant for rendering service but also to pursue scientific work, for mentoring young faculty for starting new programs.

Interested candidates are requested to submit their detailed curriculum vitae in the prescribed proforma along with the nomination on or before 15<sup>th</sup> November 2016.
