4. **Failure to submit the requisite certificate(s)/document(s) at the time of the interview, or within the stipulated date and time, will result in the candidate being deemed NOT ELIGIBLE and they will not be permitted to attend the interview.**
5. No further communication in this regard will be entertained, under any circumstances.

It is also informed that the determination of *eligibility before the conduct of Interview is purely provisional and the candidate found eligible/provisionally eligible does not confer any right on him/her being selected for the post. Any information furnished in the Application which is/are found to be wrong at a later stage, the candidature will be treated as cancelled automatically.*
