SPECIFICATION FOR Human Inhibin-B_Elisa Kit Complete with requisite calibrator and control

1. Human Sclerostin ELISA kit is only applicable
2. There should be 96 wells per kit
3. The result should be analyzed with microplate reader
4. The assay sensitivity of $< 2\text{pg/ml}$
5. The inter assay coefficient of variance should be $< 15\%$ and intra assay coefficient of variance should be $< 10\%$
