Limited quotation invited for supply of consumables as per the list given overleaf / attached and as per the enclosed format, subject to the following terms and conditions:

1. Rates should be quoted only for the items that are available in stock and can be supplied immediately upon receipt of the order.
2. Only GST is applicable
3. No insurance charges are payable as per the rules of the Government. As such, before quoting, the firms should consider all the risks in the transit and then furnish limited tender, which should also cover insurance charges. If any point is raised regarding insurance charges after orders are issued, the same will not be entertained, and the firms thereafter should affect the supply at their own cost.
4. Rates should be quoted F.O.R. Pondicherry. Extra packing, forwarding charges, etc., should not be quoted.
5. Delivery is required to be done promptly on the issue of the supply order. Tenders should please state the guaranteed delivery period they can offer. As the delivery date is the essence of the contract, this should be strictly adhered to by the successful tenderer.
6. No supply that is not according to the specifications and does not meet our requirements will be accepted.
7. The firms participating in the limited tender must have registered their firms with the purchase section of JIPMER.
8. Limited tender quotations should be sent only by/Registered Post/Speed Post/Courier. Hand quotations are not accepted.
9. Purchase preference will be given to MSE and Vendors of products that fall in "Make in India" criteria as per prevailing Govt. Orders. Purchase preference is only for manufacturing MSE and not for trading MSE.
10. In case the manufacturer falls in the MSE category, they have to submit the self-attested copy of the Udyogaadhaar certificate along with the bid documents for claiming MSE Benefits, failing which purchase preference will not be given
11. Vendors claiming "Make in India" purchase preference must submit a self-certified declaration indicating the percentage of local content in the product offered and the place in India where the local content value addition was carried out along with the bid documents failing which purchase shall not be given.
