Sub: Stray vacancy round counselling for the vacant MBBS 2020-21 session seats of JIPMER Puducherry and JIPMER Karaikal campus – INTERNAL (Puducherry domicile) according to the **directions received from Medical Counselling Committee (MCC)**

With reference to the above Judgements received from the Hon'ble Supreme court, the Hon'ble Madras High court and as per the directions of the Medical Counselling Committee, the stray vacancy counselling for vacant JIPMER INTERNAL (Puducherry domicile) seats in JIPMER Puducherry and JIPMER Karaikal campuses will be conducted as detailed below.

*If eligible candidates are not available, as per the MCC guidelines, the seat will be converted to SC category.

1. The counselling for JIPMER Puducherry seats will be conducted first followed by counselling for JIPMER Karaikal seats.
2. Only the **candidates who are on the list published by MCC** on 12th January 2021 (Ref: U-11011/04/2020-MEC) are eligible to participate in this counselling.

3. **Physical presence** with all the **original certificates** (as given in Appendix A including Puducherry domicile as given in the JIPMER MBBS Prospectus 2020-21) is mandatory to take part in the counselling.
4. Under any circumstances, authorised representatives will NOT be allowed to participate and **bonafide** certificates will **NOT** be accepted.
5. Candidates participating in stray vacancy round counselling for INTERNAL (Puducherry domicile) seats **should NOT report earlier than the mentioned time.**
6. Only candidates whose names figure on the list of eligible candidates published by MCC on 12th January 2021 should report for counselling. **Entry of the candidates to the counselling venue, whose names are not published in the MCC list will NOT be permitted. Kindly note parents will not be permitted inside the counselling venue**
7. **Medical Examination:** The candidates who have been allotted a seat will undergo medical examination after the counselling on the same day by a duly constituted medical board.
8. The selected candidates should submit a Demand Draft for **Rs. 12,620/-** for payment towards academic fee to complete the admission procedures. The Demand Draft should be made in favour of the Director, JIPMER, Puducherry payable at Puducherry.
9. The selected candidates to JIPMER Karaikal campus will be transported to Karaikal Campus on 15-01-2021, 05:00 PM by Institute vehicle **only** and outstation candidates will be quarantined for **7 days**. Parents if they wish to visit Karaikal campus, they should make their own transport arrangement. However, parents will not be allowed to enter the quarantine facility.
10. The candidates are instructed to visit JIPMER website periodically for updates.

Note: All admissions are provisional subject to verification of identity by the Forensic experts

Appendix - A

List of Original Certificates:

1. Medical Counselling Registration slip for stray vacancy round (to be downloaded from MCC website)
2. NEET Score Card
3. NEET Admit Card (Hall Ticket – Original)
4. Age proof certificate (Birth certificate/10th/12th Mark sheet).
5. 10th Std Mark sheet
6. 12th Std Mark sheet
7. Conduct and Character certificate from the School where he/she completed his/her Higher Secondary study.
8. Transfer Certificate
9. Migration Certificate in case of CBSE, CISCE, etc.
10. Residence/Nationality/Domicile certificate issued by Revenue authority not below the rank of Tahsildar/Dy. Tahsildar or Aadhar card/Voter ID/Passport.
11. Community Certificate/EWSs Certificate (if applicable):
 - a) For OBC Category:
OBC (Non-Creamy Layer) certificate must be in the format as mentioned as per NEET 2020 Information brochure. OBC (NCL) certificate to be produced at the time of interview should not be older than one year on date of counselling.
 - b) For SC/ST Category:
SC/ST certificate must be in the format as mentioned as per NEET 2020 Information brochure.
 - c) For EWS category:
Reservation for Economically Weaker Sections (EWSs) shall be applicable as per Govt. of India policy Office Memorandum No. 36039/1/2019-Estt (Res) DoPT dated 19th January 2019 and 31st January 2019. EWSs Candidates will attach current certificate issued by the competent authority in the form prescribed.
The certificate should be issued by the Revenue Officer not below the rank of Tahsildar/Dy. Tahsildar if he/she belongs to SC/ST/OBC/EWS category. In case the certificates in regional language, the English version of the certificate duly attested by a Gazetted Officer should also be furnished.
12. For Non-Resident Indian candidates:
Recent NRI Status certificate of the parent or candidate issued by the Indian Embassy of the respective Country with the Embassy seal.
13. For Overseas Citizen of India: Certificate of Registration for Overseas Citizen of India.

Shortlisted candidates should bring all original documents and photocopies of all necessary documents along with 6 passport size photographs on the day of counselling.
