Based on the scrutiny of applications for recruitment to faculty posts namely Professor, Additional Professor, Associate Professor and Assistant Professor on regular basis in various disciplines, the list of **eligible & provisionally eligible** candidates to appear for **Phase I and Phase II** interview is enclosed as **Annexure 1** and **Annexure 2** respectively.

**The interviews will start tentatively from 3<sup>rd</sup> week of December, 2022 onwards.** The interview schedule for each Discipline will be published shortly. The **interview** will be held **in-person** at **The Tamil Nadu Dr. M.G.R. Medical University, Chennai**. Interview call letter to the eligible/provisionally eligible candidates will be sent to the registered email ID of the candidates in due course.

The **candidature of the provisionally eligible candidates** (listed in Annexure 2) for the interview will be **subject** to submission of the requisite certificate(s)/document(s) mentioned against his/her name **on the day of interview during certificate verification**. Failure to submit the requisite certificate(s)/document(s), the candidate will not be allowed to appear for the interview.

The eligibility of the candidate at this stage is purely provisional and the candidate being merely adjudged as Eligible/Provisionally eligible does not confer any right on him/her being selected for the post. If at any time during the selection process, it comes to the notice that a candidate has filled wrong entries/does not possess the required qualification as per the Recruitment Rules of the post(s), he/she will be treated/declared as Not eligible and his/her candidature will be treated as cancelled.

The list of applicants found **not eligible** is enclosed as **Annexure 3**. In case of any objection/clarification (if any) regarding his/her eligibility, **he/she may send the objection/ clarification along with relevant document(s) by email to [aiimsmadurai.fac@gmail.com](mailto:aiimsmadurai.fac@gmail.com) on or before 18.11.2022, Friday by 4.30 PM.** The objections/clarifications received after 4:30 PM on 18.11.2022, Friday will not be considered.

**The eligibility list for remaining Departments will be published in due course and the interviews will be held in a phased manner.**
