1. Rates should be quoted only for the items which are available in stock and can be supplied immediately upon receipt of order.
2. Only GST is applicable
3. No insurance charges are payable as per the rules in the Government. As such, the firms, before quoting should take into consideration all the risks in the transit and then furnish limited tender which should cover insurance charges also. If any point is raised regarding insurance charges after orders are issued, the same will not be entertained and the firms thereafter should affect the supply at their own cost.
4. Rates should be quoted F.O.R Pondicherry. Extra packing, forwarding charges etc. should not be quoted.
5. Delivery is required to be done promptly on issue of supply order. Tenderers should please state the guarantee delivery period they can offer. As delivery date is essence of the contract, this should be strictly adhered to by the successful tenderer.
6. No supply, which is not according to the specifications and not meeting our requirement, will be accepted.
7. The Principal Investigator shall have the right to reject the limited tender in whole or part without assigning any reason thereof.
8. The firms participating in the limited tender must have registered their firms with purchase section of JIPMER.
9. Limited tender quotations should be sent only by/Registered Post/Speed
10. Purchase preference will be given to MSE and Vendors of products that fall in "Make in India" criteria as per prevailing Govt. Orders. Purchase preference is only for manufacturing MSE and not for trading MSE.
11. In case the manufacturer falls in MSE category, they have to submit a self-attested copy of Udyog Aadhaar certificate along with the bid documents for claiming MSE Benefits failing which purchase preference will not be given
12. Vendors claiming "Make in India" purchase preference must submit self-certified declaration indicating the percentage of local content in the product offered and the place in India where the local content value addition was carried out along with the bid documents failing which purchase shall not be given
13. The quotation should be valid for 1 year.

1	Flocked Nylon Tipped Swab	<ul style="list-style-type: none">• Viral transport medium must contain protective protein, antibiotic to control microbial and fungal contamination and cryoprotectant to help preserving the virus for long term frozen storage.• pH should be maintained around 7.3 ± 0.3. It must also contain phenol red indicator in the medium to ensure medium integrity at the time of sample collection.• Nasopharyngeal and oropharyngeal synthetic swab (nylon/polyester/rayon/Dacron).• The medium must be provided in a 10/15 ml screw capped leak proof container with labeling stickers. Swabs must be individually packed in an easy to peel pouches.• Kit storage temperature must be 2-30 deg Celsius and the supplier should ensure that the kit is maintained at the recommended temperature during storage and shipping.• Manufacturer should be ISO:13485 certified and the product must have been validated by NIV-Pune or any other ICMR validation center.• Shelf life from date of manufacture must be at-least 1 year.	100 in each pack	02

Note:

1. The Kits should be supplied with long expiry. Short expiry kit will be rejected
2. The Selected firm must supply the kits in a staggered manner as per the instruction of the Project Investigator.
3. Make and catalog No. should be mentioned. The quotations should contain quantity of items per pack failing which the tender will be rejected
