1. Rate should be quoted only for the items, which are available in stock and can be supplied within the stipulated time as mentioned below.
 2. Price for each item must be quoted separately. The firms participating in the limited quotation must have registered with the purchase section of JIPMER before the last date of submission. If not the firms may register before quoting their rates. Quotation from unregistered firms will not be accepted. For more details in this regard, please see the JIPMER Website: www.jipmer.edu.in.
 3. Rate should be quoted inclusive of all tax including GST as per the government norms.
 4. No insurance charges are payable as per the rules in the Government. As such, the firms before quoting should consider all the risks in the transit and then furnish limited tender which should also cover insurance charges. If any point is raised as regards insurance charges after orders are issued, the same will not be entertained and the firms thereafter should affect the supply at their own cost.
 5. Rate should be quoted for JIPMER, Puducherry. Extra packing forwarding charges etc., should not be quoted.
 6. Delivery is required urgently **within 30 days** from the date of issuing the supply order. Tenders should please state the guaranteed delivery period they can offer. As the delivery date is the essence of the contract, this should be strictly adhered to by the successful tenderer.
 7. The consumables and non-consumables supplied should have an expiry period of **18- 24 months from the date of delivery**.
 8. Supply which is not according to the specifications and not meeting our requirement will not be accepted.
 9. The Principal investigator shall have the right of rejecting the limited tender in whole part without assigning any reason, therefore.
 10. In the case of high precision equipment, the firms should give a guarantee certificate for their satisfactory performance.
 11. Limited tender quotations should be sent only by SPEED POST/COURIER. Hand quotations are not accepted.


